



## Greensboro Farmers Market Campus Rules & Regulations

- The Mission of the Greensboro Farmers Market is to provide Greater Greensboro with opportunities to purchase and learn about local foods and crafts while interacting with producers and each other in a friendly and diverse social setting.
- Only approved vendor applications are permitted to sell. No solicitation or peddling permitted\*Reference: GSO Code of Ordinances: Ch. 20, Art. 1
- Solicitation for public information is permitted only at the Yanceyville St entrance to the Market building; no closer than 20 feet from the door. Campaigning is not permitted in the facility and solicitors shall not disrupt the operations of the Market; impede foot or vehicular traffic; or create a safety hazard.
- Vendors or approved non-profit groups may not have petitions or other materials unrelated to their products, operations or mission at their tables.
- Assistance animals are welcome with appropriate certification. Pets are allowed on the lawn.
- All weapons prohibited. \*Reference: GSO Code of Ordinances: Ch. 18, Art. 2, Sec. 18-25
- Greensboro Farmers Market expects all vendors, customers and visitors to conduct themselves in a polite a courteous manner, consistent with our Mission.
- Disorderly conduct such as violent behavior or abusive language that might provoke a breach of peace or creation of physically offensive or dangerous condition is unlawful and prohibited. \*Reference: GSO Code of Ordinances: Ch. 18, Art. 1.
- Alcohol sales as approved by the NC Beverage Control Commission, the City of Greensboro Special Events Office and market management approval.
- Smoking is prohibited in the facility and entrances. Smoking permitted only in designated areas away from entrances to the facility. \*Reference: GSO Code of Ordinances: Ch. 10, Art. 1, Sec. 10-6.
- No dumping or littering or use of campus trash cans or dumpsters. \*Reference: GSO Code of Ordinances: Ch. 26, Art. 1, Sec. 26-11.
- No loitering. \*Reference: GSO Code of Ordinances: Ch. 18, Art. 3, Sec, 18-46.
- No trespassing dusk to dawn. \*Reference: GSO Code of Ordinances: Ch. 18, Art. 1, Sec. 18-1.
- Sex offenders prohibited. \*Reference: GSO Code of Ordinances: Ch.18, Art. 2, Sec. 18-29.
